DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#13 is a high 2-1/2 story detached frame house approximately two bays square with no extensions. It is sheathed with German siding. The remains of a four panel door occupies the right (north) bay and had been approached by a high twelve or thirteen step wooden porch, now gone.

First story windows are 6/6 sash with those above being Colonial style, 6/3 sash. The rear is entered by a plain board and batten door.

The roof has a low slope "A" frame now covered by metal and only a modern (?) pipe driveway is apparent.

This house rests on an outcropping of fieldstone and a 7' high cut fieldstone foundation.
