DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached tall pair of 1-1/2 story brick houses four bays wide and approximately three in depth with a two story brick "T" shaped wing two bays square with a wide attached chimney at the rear. Side balconies are now enclosed. All brick-work is laid in common bond.

Simple four panel doors occupy the end bays with rectangular transoms (closed on #19) and are approached by high, eleven step frame porches. Because the building sets on an outcropping of fieldstone, the cellars are at street level with #19 having a front board and batten cellar door. All windows are of 6/6 sash with wood lintels and sills. The attics are lighted by 6/6 sash at the gable.

The metal covered moderate slope "A" frame roof rests on two string brick cornices and a small enclosed chimney rises from each end. The wing roofs slope gently to each side.

The building sets on a high fieldstone foundation.
