DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached pair of tall brick 1-1/2 story houses approximately four bays square with a 1-1/2 story brick "T" shaped wing two bays square and with a wide detached chimney at the end. This wing originally had overhangs on each side but #29 has been altered to two stories.

Newer doors occupy the end bays which are approached by high ten step porches. Windows are of 6/6 sash with wood lintels and sills including the side attic window.

The building is covered by a broad metal steep sloped "A" frame roof resting on two string brick cornices. Small enclosed chimneys rise from each end. The house rests on a high fieldstone foundation.
