**Description of Property and Eligibility Determination:** *(Use continuation sheet if necessary and attach map and photo)*

The Eli Kinsinger Farm is located at 11505 National Pike. The house is a cross gable, two-story, frame house with Italianate details. The five bay front façade has five two over two, double-hung, wood sash windows on the second level, an arched two over two window in the front gable and four two over two, double-hung, wood sash windows on the first level. In addition to the main dwelling, the property contains two large dairy barns, several sheds, a windmill and a Grossvader, or secondary dwelling house.



This land was originally surveyed as Military Lots 2062, 2063, and 2064. In 1859 Perry Shulls deeded the land to William Stanton. The property remained in the Stanton family passing to Uriah Stanton in 1882. By 1940, Ruth Stanton deeded the land to DR. R.N. and Lorraine Davis. The property now belongs to Michael and Kay Beachy.

The property does appear to be eligible for listing in the National Register of Historic Places as part of a larger context due to the association with the National Road and the contribution the road has made to our history. The land has been in continuous use as a dairy farm since the mid-1800s. The buildings have retained their architectural integrity.



The Eli Kinsinger Farm is located at 11505 National Pike in Grantsville, Garrett County, Maryland. The farm structures sit amid seven acres of rolling dairy land approximately 1,100 feet north of National Pike. In addition to the main dwelling, the property contains two large dairy barns, several sheds, a windmill and a secondary dwelling house. The principal dwelling, constructed circa 1897, is an Italianate frame house with a stone foundation in an L-plan with a cross-gable roof. The house has two full stories plus an attic and a cellar. It measures five bays by four bays. The roof is covered with tarpaper and the original wood siding has been covered with aluminum siding. The windows are two-over-two, double-hung, wood sash with plain wood trim. The centrally placed door is a paneled wood door with a six light opening with a storm door. There is a single double-hung round arch window in the front gable. The three center bays on the first story of this façade are sheltered by a hip-roofed porch which is supported by four square columns and two pilasters. Large, ornately scrolled, decorative brackets embellish each support.

The Eli Kinsinger Farm, constructed circa 1897, is historically significant under Criteria A and C of the National Register of Historic Places. Contextually, the farm relates to the development of farmsteads along the National Road. The house meets National Register Criterion C in the area of Architecture as one of the best residential examples of the Italianate style in the county. The property does not appear to meet the National Register Criteria B or D.

The Eli Kinsinger Farm is located at 11505 National Pike in Grantsville, Garrett County, Maryland. The farm structures sit amid seven acres of rolling dairy land approximately 1,100 feet north of National Pike. In addition to the main dwelling, the property contains two large dairy barns, several sheds, a windmill and a secondary dwelling house. The principal dwelling, constructed circa 1897, is an Italianate frame house with a stone foundation in an L-plan with a cross-gable roof. The house has two full stories plus an attic and a cellar. It measures five bays by four bays. The roof is covered with tarpaper and the original wood siding has been covered with aluminum siding.

The symmetrical main façade has four windows that are two-over-two, double-hung, wood sash with plain wood trim on the first story and five on the second story. The centrally placed door is a paneled wood door with a six light opening and a storm door. There is a single double-hung round arch window in the gable. The three center bays on the first story of this façade are sheltered by a hip-roofed porch which is supported by four square columns and two pilasters. Large, ornately scrolled, decorative brackets embellish each support.

The west and east façades each have four two-over-two, double-hung, wood sash windows. The west façade features an external brick chimney.

The rear ell projects from the north façade and measure two bays long by one bay wide. The west façade of the ell features four two-over-two double-hung, wood sash windows. The east façade of the ell has two two-over-two double-hung, wood sash windows and a wood paneled door with four lights. A shed-roofed porch at the first story level extends along the ell and the north façade. The north façade of the ell has no openings. The cellar can be easily accessed by a door under the rear porch.

Outbuildings on the property include two bank barns, a corn crib, a shed, a windmill, and a garage. A two-story frame dwelling, constructed in 1951, is also situated on the farm. The west bank barn is supported by a mortise and tenon frame of circular sawn lumber and rests on a foundation of coursed, roughly-squared stone.

The Eli Kinsinger Farm, constructed circa 1897, is historically significant under Criteria A and C of the National Register of Historic Places. Contextually, the farm relates to the development of farmsteads along the National Road. The house meets National Register Criterion C in the area of Architecture as one of the best residential examples of the Italianate style in the county. The property does not appear to meet the National Register Criteria B or D.

Early European Settlement of Garrett County was little more than the forging of a new frontier. Spurred by the establishment of the Ohio Company of Virginia, permanent settlements on the land consisted predominantly of log structure, none of which survive. (Ware 1991) The thin soil covering the region and the short growing season encouraged an agricultural base in Garrett County of primarily dairy and livestock. The Industrial Revolution was brought to Garrett County in the nineteenth century by the Baltimore and Ohio Railroad. Coal and timber companies came in search of raw materials for fuel. (Schlosnagle 1978) By the late nineteenth and early twentieth century an increase of sawmills operating in the area promoted the construction of balloon-frame and vertical plank buildings as replacements for the early log structures. (Ware 1991)

The emergence of transportation routes contributed to the area's history. Braddock's Road, the route Major General Edward Braddock followed on his way to Fort Duquesne in 1755, was established along the trail taken by George Washington the previous year to Fort Necessity. Later developed for the National Road, the route was established by the U.S. Congress in 1806 as the nation's first interstate highway and "would link the eastern seaboard with the western interior" (Marriott 1995). By the 1920s the National Road became US Highway 40: a chief transcontinental highway stretching to San Francisco, California. In 1976 the National Road was designated as a National Historic Civil Engineering Landmark. The National Road carried people and consumer goods west from such eastern cities as Philadelphia and Baltimore. Traveling along the National Road, livestock and other agricultural commodities were transported to eastern markets. Homesteads, taverns, and drove yards were founded at regular intervals along the corridor.

The Eli Kinsinger Farm is one such homestead developed along the National Road. The farm is situated on a tract of land known in its early history as Grassy Cabin. Granted to Thomas Bassett by Lord Baltimore in 1768, Grassy Cabin was never settled by Bassett himself. By 1801, John Sloan had purchased most of the tract, renaming it Sloan's Ville; however, by 1815 the settlement was abandoned. (Schlosnagle 1978) Land Records from 1877 indicate that the land was granted to John W. Blocher by trustees for the estate of Jacob Blocher, who called Grassy Cabin his home at the time of his death. Ten years later John Blocher gave the property, which according to the land record included a house, to his wife, Ellen Blocher. The land was dubbed the Blocher Home Farm, according to a survey conducted by N. Spellman of Friendsville, Maryland. The farm left the Blocher family in 1934, under foreclosure by the Maryland-Virginia Joint Stock Land Bank of Baltimore. The deed at the time of foreclosure was held in mortgage by the children of deceased Ellen Blocher. Lorraine Lomison Davis acquired the property in February of 1934. The land changed hands again in 1944 when Lorraine Davis sold the farm to Eli Yoder and his wife Amanda. Eli Kinsinger purchased the land from Eli Yoder in 1949. The farm remains in the Kinsinger family today belonging Eli's son, Marvin and his wife Shirley.



**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Eli D. Kinsinger Farm consists of a late nineteenth century house and barn, and several mid-twentieth century outbuildings. The house is a two story, gable-roofed, frame building on a foundation of coursed roughly squared stone. Its basic configuration is a five bay by two bay, center hall plan with a two story near ell and both facade and rear porches.

The facade (SW elevation), has a symmetrical, five bay, center door arrangement with a central cross gable. The windows on this elevation, as well as all other elevations, are 2/2 sash. A round arched 2/2 sash window pierces the gable. The three center bays of the facade are sheltered by a flat-roofed porch supported by four square columns and two pilasters. Four very large, ornate scroll brackets embellish each column.

The southeast and northwest endwalls are both lit by four 2/2 sash windows, two per floor.

The rear ell projects from the northern end of the northeast elevation, measuring two bays long by one bay wide. A shed-roofed porch extends across the rear of the main block and continues around to the southeast side of the wing.

The exterior walls have been sheathed with aluminum siding, which obscures the original wall treatment and also caused the removal of all door and window surrounds. Tarpaper covers the roof on the facade side of the ridgeline, while corrugated metal covers the rear.

The gable-roofed bank barn is supported by a frame of circular sawn lumber that is mortise and tenoned together, and rests on a foundation of coursed, roughly squared stone.

Outbuildings on the property include another frame bank barn, a corn crib, a shed made of corrugated metal, a windmill, and a garage. A two story, frame dwelling built in 1951 is also situated on the farm.


