DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame house is situated on a bank in a hilly, wooded area, just south of Garrett County-Somerset County line. The house faces east. It is a two story three bay by two bay structure with a gable roof with exposed rafter ends. A single story shed addition is located on the rear, west elevation. A plain wooden hipped roof porch runs across the facade. The facade entrance has a four panel door.

The house has a central brick chimney. There are four one over one sash windows, two on the facade and two on the north elevation; all other windows are boarded up. The house rests on a poured concrete foundation. Weatherboards secured by wire nails cover the house. Corrugated metal covers the roof.


