DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame farmhouse is situated in a hilly area on Westernport Road approximately ½ mile southwest of the intersection with Twin Churches Road. The house faces west. It is a two story, three bay by one bay gable roof structure with a one bay by one bay ell extending from the center of the rear, east elevation. A single story, three bay by one bay shed addition is located on the south elevation of the ell. A single story shed enclosure runs the length of the facade. A small porch is located along the north elevation of the ell. The house can be entered from the west elevation of the facade addition, the south elevation of the shed addition and from the porch on the north elevation.

A central brick chimney is located on the main block and an interior brick gable end chimney is located on the south elevation of the ell. Predominately, one over one sash windows light the house with three over one windows on the second floor facade and south elevation. Plain narrow flat boards frame the windows. The house rests on a stone foundation. Aluminum siding covers the house with asphalt shingles on the roof.

A barn with a poured concrete foundation as well as a chicken house and a corn crib are located on the property west of the house. A cave is located to the north.
