## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The John Ogg Farm consists of a mid nineteenth century frame dwelling, a late nineteenth century frame bank barn, smokehouse, and wood/coal shed, as well as several other early to mid twentieth century frame outbuildings. The house is a two story, gable-roofed, frame building on a foundation of coursed, roughly-squared stone. Its basic configuration is a five bay by two bay, center hall plan with an exterior stone chimney and a circa 1910, two story, rear addition.

The facade (E elevation) has a symmetrical five bay, center door arrangement and a full length porch. The windows on this elevation, as well as the other elevations on the main block, are 1/1 sash replacements. Its shed-roofed porch, with four Tuscan column supports, appears to be a twentieth century addition.

The stone chimney on the north endwall is a shouldered stack made of rock-faced ashlar. Sash windows flank the chimney on the first and second floor levels, while two small casements pierce the gable. The south endwall has two sash windows per floor and two four-pane casements in the gable, as well. A box cornice with partial gable end returns outlines the eaves.

The rear wing, which measures two bays long by one bay wide, projects from the center of the west elevation creating a T-plan. Elongated 1/1 sash windows light its north and south walls, while an interior brick chimney rises through the center of its unfenestrated enwall. Shed-roofed porches shelter the full length of both north and south elevations.

The entire exterior of the house is sheathed with aluminum siding.

Hand-planed, vertical plank partition walls divide the interior into a double pile, center hall plan, the front rooms being slightly larger than those in the rear. The wall between the two rooms on the north side of the hall has been removed. The north front room, which contains the stone fireplace, originally served as the kitchen. This room now functions as a living room, and the kitchen has been moved to the rear wing.

The hall is very wide and has a staircase on its north wall with 14 grained risers leading to a landing at the second floor. From the landing, two more stairs climb in the reverse direction. The newel post is a slender turned column, square at the top and bottom, with a ball to grasp near the handrail. Square balusters (1" x 1") are spaced two per tread. On the second floor an enclosed staircase leads to the attic.

The first floor retains many of its original details. Its two-panel doors, molded door and window surrounds, and plain board baseboards are all painted with grained wood finish. The walls and ceilings are paneled with hand planed, random width boards. According to the present owner, the stone fireplace, now altered, originally had a very large hearth because it was used for cooking. There was also a fireplace in the basement, but the opening there has been blocked.

The barn, located directly south of the house on the opposite side (S side) of t road, is supported by a circular sawn frame and a foundation of coursed, roughly squared stone. Its exterior walls are covered with vertical board, and have louvered vents in their endwalls.

**STATEMENT OF SIGNIFICANCE**

Oral tradition holds that the original settler on this property was a Mr. Brunne~~m~~an, and that the house was built by Mr. Ogg, a later owner.<sup>2</sup> There is no record of Bren~~n~~eman in the chain of title, but we do find John Ogg and John Warnick buying the property, called "Springfield", in 1851.<sup>3</sup> Whether John Ogg was really the builder of the house is uncertain. The value of the property rose sharply before he bought it and then stayed fairly constant during his ownership.

It is thought that one of the early owners of this property, possibly John Ogg, tried to raise tobacco and erected a log barn to dry it. The tobacco crop failed due to inappropriate climate, but the barn was later used as a blacksmith shop by ~~Christian J. Otto~~, owner from 1878 to 1910.<sup>4</sup>



Continuation #7 Description

The smokehouse is a very small, gable-roofed building constructed of two layers of vertical plank on a poured concrete foundation.

Other outbuildings include a workshop, a cow shed, a chicken coop, a corn crib, and several other undetermined frame buildings.

A log outbuilding was previously located south of the house, just over the south side of the road. No traces of it remain, but the owner thinks that it was built as a tobacco<sup>1</sup> barn and remembers it being used as a blacksmith shop by her grandfather.
