DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame farmhouse is situated in a hilly area off Green Lantern Road, approximately 5/8 miles northeast of the intersection with Sam Crow Road. The house faces east. It is a story and-a-half three bay by two bay gable roof structure with two gable roof dormer (the half story) extending from the facade roof. The roof of the house extends out to form the roof of the porch which is supported by wooden turned posts. A single story, three bay by one bay shed addition is located to the rear half of the south elevation. The house is enter from this addition as well as the central facade entrance with transom.

An interior brick chimney is located at the roofs peak slightly to the south end. One over one sash windows light the house topped with drip cap molding. Double windows appear on the first story facade. The house is covered with the original, narrow German siding framed with cornerboards. The roof is covered with corrugated metal.

A barn, springhouse and wash house are also located on the property.
