Milestone No. ---(187) and its small mound of earth mark Mason and Dixon's 172nd mile west of the northeast corner of Maryland, the beginning of their West Line, the English provincial boundary later known as the Mason-Dixon Line, famous for its historical impact and innovative survey methods. The monument is a very plain dressed marble post with a low pyramidal top, quarried and carved in Cockeysville, Maryland; is in good condition, unaltered, firmly in place but out of plumb (leaning to the southeast); measures 10 inches square by about 13 inches high above the mound; and is embellished only by the capital letter P on the north side facing Pennsylvania, M on the south side facing Maryland, the year 1767 on the east side (when/^{this site}originally surveyed and marked), and 1902 on the west side (^{the monument was}when/added ~~to~~ the center of the mound during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary. The mound is also in good condition, is presumed to be the remains of the original cairn, with the monument replacing the original wood post long since gone. Although not measured at the site, it appears/^{from photos}to be about 10 feet in diameter by about 1½ feet high at the center. On the national and state levels, No. ---(187) and its mound are significant primarily as being among the thematic group series of some 248 markers still visually defining the West Line. Locally, as among the 42 markers along the present Garrett/Somerset-Fayette county boundary, they are also significant symbolically for their identifiable relationship to the colonial and Civil War heritage of these counties.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Milestone No. ---(187) and its small mound of earth mark Mason and Dixon's 172nd mile west of the northeast corner of Maryland, the beginning of their 230.228-mile West Line. The monument was a new dressed Cockeysville marble post with a low pyramidal top when added to the center of the mound in 1902 during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary. It is in good condition, unaltered, firmly in place but ^{leaning to the southeast} out of plumb, measures 10 inches square by about 13 inches high above the mound; and is embellished only by the capital letter P on the north side facing Pennsylvania, M on the south side facing Maryland, the year 1767 on the east side (when originally surveyed and marked), and 1902 on the west side. The mound, also in good ^{unaltered} condition, was not measured at the time of the site survey but appears from photos to be about 10 feet in diameter by about 1½ feet high at the center, and is believed to be ^{the remains of} an original cairn of 1767.

The area here is ^{the} sparsely settled, rumples foothills of Meadow Mountain about 1½ miles to the west, with several large farms surrounded by dense woodlands. The site is within Election District 9 of Garrett Count, MD, and Greenville Township of Somerset County, PA; about 3½ miles southeast of the town of Salisbury, PA; about 3½ miles northeast of the scattered settlement of Piney Grove, MD; about 3000 feet south of the Salisbury-Pocahontas Road (LR-55002); at a point about 40 feet south of the new gas pipeline under construction and the north edge of a dense hemlock-deciduous woods, in a low-lying swail close ^(just north of) to a tributary of Piney Creek, in a mossy bower encircled by hemlocks (whose roots have probably been the cause of pushing the monument out of plumb).

The monument, identical to 65 other monuments of 1902 set west of Sideling Hill to visually reestablish the Maryland-Pennsylvania boundary, was quarried and carved in Cockeysville, MD, of a white, fine-grained marble called saccharoidal dolomite or magnesian limestone; was originally cut about 10 inches square by about 4½ feet long, intended for setting about 1½ feet above ground with the remaining 3 feet for setting into the ground, thus eliminating the need for a concrete foundation. The letters and numbers are blocky, V-sunk without serifs, and are horizontally aligned as a band around the stone near the top. These, and the top planes are clear and intact, but there are chips along all vertical edges and the top corners, and a small hole in the apex. 
