

ABSTRACT

MASON-DIXON LINE: MILESTONE NO. ---(188) 1767 (mound), 1902 (monument)

Milestone No. ---(188) and its small mound of stones mark Mason and Dixon's 173rd mile west of the northeast corner of Maryland, the beginning of their 230.228-mile West Line, the English provincial boundary later known as the Mason-Dixon Line, famous for its historical impact and innovative survey methods. The monument is a very plain dressed marble post with a low pyramidal top, quarried and carved in Cockeysville, Maryland; is in excellent condition, unaltered, firmly set (though slightly out of plumb); measures 10 inches square by about 15 inches high above the mound; and is embellished only by the capital letter P on the north side facing Pennsylvania, M on the south side facing Maryland, the year 1767 on the east side (when the site was originally surveyed and marked with a cairn), and 1902 on the west side (when this new monument was added to the center of the mound during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary). ^{also in excellent condition,} The mound ^{is} of loose stones, originally gathered from the site and heaped around the wood post, now replaced by the monument. It measures a roughly estimated 7 feet in diameter by about 2 feet high at the center. On the national and state levels, No. ---(188) and this mound are significant primarily as being among the thematic group series of some 248 markers still visually defining the West Line. Locally, as among the 42 markers along the present Garrett/Somerset-Fayette county boundary, they are also significant symbolically for their identifiable relationship to the colonial and Civil War heritage of these counties.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

/ According to the 1900-03 Resurvey Milestone No. --- (188) and its small mound of stones mark Mason and Dixon's 173rd mile west of the northeast corner of Maryland. The monument was a new dressed marble post with a low pyramidal top when added to the mound in 1902 during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary. It is in excellent condition, unaltered, firmly set (but slightly out of plumb); measures 10 inches square by about 15 inches high above the mound; and is embellished only by the capital letter P on the north side facing Pennsylvania, M on the south side facing Maryland, the year 1767 on the east side (when the site was originally surveyed and marked), and 1902 on the west side. The mound is also in excellent condition, presumably originally erected as a cairn in 1767, with the present monument replacing the wood post long since gone. It was not measured at the site but is an estimated 7 feet in diameter by about 2 feet high at the center.

The area here is the ^{high} rugged, rather steep, densely wooded ^{stone} western slope of one of the ^{string of} mountains forming Red Ridge. The site (shown on the Resurvey engineer's map but not the USGS quadrangle) is within Election District 3 of Garrett County, MD, and Greenville Township of Somerset County, PA; about 2½ miles southeast of the town of Salisbury, PA; about 3 miles northeast of the scattered settlement of Piney Grove, MD; about 2000 feet east of Meyersdale Road/T-496; about 1000 feet east of the confluence of Red Run with Piney Creek; at a point about 70 feet south of the old pipeline, in the woods (south of the pile of woodland debris shoved up along (and parallel to) the new pipeline under construction. It cannot be seen from any road or pipeline, is well camouflaged by fallen trees and difficult to spot even closeup; and is protected by this inconspicuous setting.

The monument, identical to 65 other monuments of 1902 set west of Sideling Hill to visually reestablish the Maryland-Pennsylvania boundary, was quarried and carved in Cockeysville, MD, of a white, fine-grained marble called saccharoidal dolomite or magnesian limestone; was originally cut about 10 inches square by about 4½ feet long, intended for setting about 1½ feet above ground with the remaining 3 feet for setting into the ground without the need for a concrete foundation. The letters and numbers are blocky, V-sunk without serifs, and are horizontally aligned as a band around the stone near the top. These and the top planes and apex are all clear and intact; though there is a small chip at the





