
The ~~Belva McKenzie Farm~~ is located at 1157 Meyersdale Road. The main dwelling is a cross gable, two-story, stone house constructed in the early 20th century. Outbuildings include a bank barn with vertical siding, springhouse and garage all built of the same stone. There is a two-story brick structure of unknown use. This mystery building has five, four-light window on the first floor and fourteen windows of the same configuration on the second floor and a stone foundation. The main dwelling has replacement windows on the second floor and a porch addition in the rear. Barbara Glotfelty's husband, Israel Glotfelty, transferred this parcel of land to her and her heirs in 1903. There is no deed reference prior to 1903. Clyde Glotfelty deeded the land to Edgar and Catherine Michael on November 23, 1939. The current owners, Tony and Patricia Flanagan, bought the property in 1992. The property does not appear to be eligible for listing in the National Register of Historic Places.


