## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This plank constructed frame house is situated in a hilly area north of Gravel Hill and faces east. It is a three bay by two bay, two story structure with a gable roof. A single bay deep ell addition is located off the rear, west, elevation. An enclosed front addition covers the facade. There is a central entrance.

Exterior brick chimneys are located at the rear of the ell addition and on the north gable end. One over one sash windows light the house. The house is covered with asbestos shingles and asphalt shingles on the roof. The original siding, now covered, is weatherboard. It rests on a stone foundation.

STATEMENT OF SIGNIFICANCE

This house is an example of a common western Maryland type. Houses of this general configuration, a rectangular main block and rear kitchen wing, were constructed in Garrett County from the late nineteenth through the early twentieth centuries.

The house was constructed by Christian Paul, the father of the present owner, sometime around the year 1890.


