DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Andrew Rosenberger House is located in open hilly terrain at the base of Little Savage Mountain's western slope.

It is a two-story 5-bay by 2-bay cross-gable house with an ell addition. It rests on a stone foundation, has asphalt siding (original siding is not detectable), and a standing seam metal roof.

The facade faces east and has a central entrance. A two-story shed porch runs across the facade, supported by 6 square wooden posts at the first and second story. There is a solid paneled balustrade at the second story.

All windows are 2/2 sash with plain board surrounds, except for two small 4/1 sash windows on the south elevation of the ell, a small 1/1 sash window at the attic story of the facade gable end, and a 1/1 sash window on the north elevation of a shed addition to the ell.

The one-story enclosed shed addition on the north elevation has a central entrance.

There are two interior chimneys, both in the main block of the house: one brick and one cement block.


