DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The John Finzel Farmhouse is located within the small town of Finzel on the east side of Route 546.

It is a two-story, two bay by two bay frame house with a small gable-roofed addition covering an entrance on the west elevation.

The house rests on a stone foundation, has aluminum siding (original siding is not detectable), and a corrugated metal roof. The facade faces north and has an off-set entrance at the east end. A shed porch supported by four square wooden columns runs across the facade and is approached by wooden steps at the east end.

All windows are 1/1 sash. There are two interior brick chimneys.
