The Howard Michael Farm consists of a late nineteenth century frame dwelling, a frame bank barn, and several frame outbuildings. The house is a two story, gable-roofed, building on a foundation of coursed roughly squared stone with an 1880 datestone on the northwest side. Its basic configuration is a three bay by two bay rectangular plan with a two story rear ell and both facade and rear porches. Weatherboard sheathes its exterior walls, while the roof has a covering of standing seam metal. Two stone chimneys are situated on the ridgeline.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Howard Michael Farm is located on the north side of Aaron Run Road approximately 2.1 miles northeast of its junction with Maryland Route 36 in Morrison. The farm consists of a dwelling, a barn, and several outbuildings situated on the side of a hill.

The house is a frame, two story, gable-roofed building with its facade oriented to the northeast. Its basic configuration is an ell-plan with a three bay by two bay main block and a two bay by one bay rear ell. The facade is asymmetrically arranged; the first floor has three bays with the door placed off center; the second floor's center bay is unfenestrated. A porch extends the full length of the facade and another extends the length of the northwest elevation on the rear ell.

The building rests on a foundation of coursed, roughly squared stone with an 1880 datestone on the northwest endwall. Weatherboard with cornerboards covers the exterior walls and one over one sash windows light the building. These sash appear to be replacements, however. The roof is covered with standing seam metal and has a box cornice with partial gable end returns. A stone chimney is located at the middle of the ridgeline on the main block and another is situated on the ridgeline of the rear ell.

The facade porch rests on a cinderblock foundation and has a tongue and groove floor. The four square columns and two pilasters that support its hipped roof are connected by a jigsaw railing. The rear porch rests on a square post foundation with plank flooring. Four chamfered posts and two pilasters are the supports for a hipped roof. Three rows of board between the posts serve as the railing. Both the facade and rear porch roofs are covered with standing seam metal.

A frame, gable-roofed bank barn on a coursed, roughly squared stone foundation is located northwest of the house. The exterior walls are covered with vertical board siding and the roof with corrugated metal. Its stone reinforced bank entrance is positioned on the southwest elevation.

Four small, frame, gable-roofed outbuildings on stone foundations are situated near the house. A recent frame chicken house and a cinderblock garage are also included on the property.


