DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This vertical-plank constructed house is situated in the flat flood plain of the Savage River and faces east. It is a two by three bay, two story structure with a gable end facade. A wooden front porch, supported by four chamfered wooden posts and sitting on cinderblock piers, extends the length of the facade. A shed addition, one story high, runs along the rear, west elevation. Two entrances appear on the facade; symmetrically located.

The house has a central chimney, constructed of brick and covered with cement. One over one sash windows light the second story facade and the first story west elevation. Two over two windows light the second story on the north and south elevations and the rear, and on the first story south elevation. The house rests on a stone foundation. The house is covered with German siding with cornerboards. The roof of the main structure is covered with corrugated metal. The roof of the shed addition and the facade porch is covered with tar-paper.

STATEMENT OF SIGNIFICANCE

This house is an example of a common western Maryland type. Houses of this general configuration, a rectangular main block, were constructed in Garrett County from the late nineteenth through the early twentieth centuries.

This plank constructed house was built by Ozias Weimer, the grandfather of Mrs. Layton Beeman. It has been moved three times since the building of the Savage River Dam. Ozias Weimer, the father of James, was a local house and barn builder.


