DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Jesse Green House is located .4 miles W of Westernport Road, down a dirt lane. The site includes several frame outbuildings and the land immediately around is flat and featureless. On the SE the land slopes down to a pine swamp and to the W is Elbow Mountain.

The house is a one and 1/2 story, gable-roofed, ell-plan dwelling with an asymmetrical four-bay facade. The facade points NE and a one-story, shed-roofed porch runs the length of the facade. The facade is composed of the NE gable end of the main block and the NE elevation of the ell and has two central doors with a window at each side. The SE elevation of the main block measures three bays across and has a central door.

The house rests on a low dry stone foundation and is covered with red brick-patterned asphalt over vertical boards. On the second floor of the main block on the NE elevation, the wall has been covered with horizontal boards. The first floor windows are two over two sash, while the second floor windows are two by two sliding windows. On the second floor of the NE elevation is a full-size two over two sash window. All windows have plain board surrounds.

The roof is covered with tar paper. There are two interior brick chimneys: one at the NW gable end and one NE of center on the main block. The porch roof is supported by three square posts. The interior of the house is unknown.

To the N of the house are a small springhouse and a stone foundation that may once have been a cave or root cellar. To the NE and E are three farm buildings: barn, tool shed and outhouse. The buildings are all frame. About 100 yards NE of the house a spring emerges and spills into a sunk bathtub. The overflow runs South.

The entire site is abandoned and in poor condition.
