DESCRIBE THE PRESENT AND ORIGINAL (if known) PHYSICAL APPEARANCE

The Blooming Rose Methodist Church is of a type fairly common in Garrett County. It is a simple rectangular nave with a square 'west' entrance tower. There are three stained glass filled lancets on the side walls of the church, and one on each side of the tower; the entrance door is also set within a pointed arch. Very similar to the Methodist Church at Hoyes (G-41), the tower at Blooming Rose is more pronounced.
