DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

The Frist National Bank Building located across the street from the new one storey First National Bank of Oakland, is a 2 storey plus attic brick commercial structure. A rectangular block, the bank's gable end faces the main street. The third floor 'pediment' area is covered with fish-scale shingles (slate) and there is a window (6/6 with horizontal panes) with a very simple swan's neck pediment. The cornice above the second storey runs across the front of this building forming a pent. Below this main cornice is a row of bricks set on end. The second storey front has three round head windows with stone bases and brick voussirs. The first floor has been altered with two large glass windows and double entrance door, all with aluminum trim. There is a stone base on front of the bank. There is one shaped brick chimney rising from the ridge of the roof.

STATEMENT OF SIGNIFICANCE (Include Personages, Dates, Events, Etc.)

The Friendsville Bank, a small commercial structure, appears to represent a modest attempt at Colonial Revival architecture -- the pent cornice, the swan's neck pediment, etc. -- a Georgian building in the manner of south-eastern Pennsylvania. Although slightly altered, this bank building has more integrity, more architectural presence, than the 'co-co' Colonial bank next door - its replacement. The older bank occupies an important corner location in the town of Friendsville and it definitely should not be replaced by a structure of less than two storeys.


