DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame farmhouse is situated north of a spring on land sloping very slightly to the southeast. The three-bay, true 1½-story house faces east. A two-bay by two-bay shed-roofed addition covers the rear. A front porch running the length of the dwelling includes both square and turned posts and a plain balustrade. Entrances appear in the center of the facade and in the addition's north end. The latter is protected by a bracket-supported gable roof.

Central brick stove-flue chimneys appear in the main block and at the main block's intersection with the additon. Six-pane windows light the half-story, while 1/1 sash light the rest of the house. Plain flat boards frame the windows. The stone cellar is entered from the south. German siding covers the house, with the exceptions of asphalt covering the facade's half-story, and the rear of the addition. Standing-seam metal covers the main roof. Tarpaper roofing covers the addition. The house is painted white with green trim.

Several sheds stand east and south of the house.


