DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two-story frame house faces southeast over rolling terrain. The two-part house includes the original three-bay section to the southwest and a one-bay wide by two-bay deep addition to the northeast. A one-story shed-roofed addition crosses the rear.

2/2 windows light both sections. The original section's central entrance features a six-panel door and a transom. The addition's facade entrance includes a door lit by two long windows.

The facade architraves are highlighted by a small quirk-ogee with astragal molding. The addition's longer northeast windows are framed in plain flat boards capped by a drip molding.

The building's main roof is gabled, while the addition's northeast end is hipped. Both sections stand on a cut stone block foundation.

Either end is covered with German siding. The addition's facade is covered with very narrow German siding. Flush tongue and groove boards, their edges scored to resemble a bead, sheathe the main facade. Insul-brick covers much of the siding.

The original section's frame is constructed of large hewn members, including angle braces, mortised and tenoned together.

STATEMENT OF SIGNIFICANCE

This house is an example of a common western Maryland type. Houses of this general configuration, a rectangular main block and rear kitchen wing, were constructed in Garrett County from the late nineteenth through the early twentieth centuries.

This is one of Garrett County's few examples of mid-19th century timber frame construction. Unfortunately, interior inspection was not permitted.


