## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Clarence Thornburg House is a two-story gable roofed, four bay by two bay duplex with a gable ell at the rear (S) elevation. The facade of the house, facing the road, points North. A shed porch fills in the ell on the East elevation and a hipped-roof porch adorns the facade.

The house rests on a stone foundation and is covered with brown asphalt siding. The windows are all two over two sash with cornices and plain board surrounds. The facade doors are placed in the two central bays and have singlepane rectangular transoms. The roof of the main block is covered with pressed tin; on the gable addition, the roof is standing seam metal.

The house has three flues: one brick interior end flue at each end of the main block, and one at the center of the gable addition.

The porch is supported by four turn posts with jigsawn quarter-round brackets whose centers contain two turn spindles. The porch balustrade is jigsawn.

The house is in fair condition and appears to be in seasonal use as a vacation retreat.


