The Coddington Farmstead is one of few 18th century land grants in Garrett County to demonstrate continuous occupation, and to retain an architecturally sophisticated building from the early period. The Coddington who built this farmhouse was reflecting a style common in late 18th and early 19th century tidewater Maryland. A long, narrow house one room deep, heated by an exterior stone chimney at either end, of center-hall plan with a room to either side; contrasts sharply with the square, German 3-room plan.

The original, true 1½-story, five-bay by one-bay house faces north under an east-west gable roof. Centered perpendicularly to the east end stands a two-story, three-bay by two-bay gable-roofed addition.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Coddington Homestead is located on the southeast side of a hill northwest of Selbysport on the Old Morgantown Road. The original road is still visible north of the farm. A two-part frame house and an early twentieth century frame bank barn remain on the property.

The original, true 1½-story five-bay by one-bay house faces north under an east-west gable roof. Centered perpendicularly to the east end stands a two-story, three-bay by two-bay gable-roofed addition.

The first section appears to date from the second quarter of the 19th century. Entrances occupy the center bay on either side. The end bays on the south, and the entire west gable end are unfenestrated. Two-over-two sash windows light the first floor, while two-pane casement windows light the half-story. A nine-pane casement window lights the facades central bay in the half-story. Flat-board pedimented architraves, as well as the sash, are late-19th century replacements of the original features.

A shed-roofed one-story porch supported by turned posts covers the facade. Large exterior stone chimneys, one at either end, have been replaced with one brick and one concrete block stove-flue chimney.

The Coddington House is built over a full stone cellar. In both sections of the house, asbestos shingles cover the original siding, and standing-seam metal covers the roof.

The floor plan consists of a central stair hall with one room to either side. The west room retains its beaded chair rail. The window sill drops below the level of the chair rail. Architraves exhibit flattened Greek ovolo moldings. Doors feature two long, narrow, shallow panels.

The stair, starting at the east side of the south end of the hall, includes two short runs joined by a landing running the width of the hall.

The two-room plan on the second floor is modified with a small extra closet situated along the west side of the stair.

The owner states that the house is a wood frame structure. Although the construction is not presently visible, one would expect a building of this date to have fairly heavy timber-framed construction. In the cellar, entered under the main stair, 14" wide log joists, hewn on two sides, are visible.

STATEMENT OF SIGNIFICANCE

The Coddington Farmstead is one of few 18th century land grants in Garrett County to demonstrate continuous occupation, and to retain an architecturally sophisticated building from the early period. While most extant buildings from the early 19th century are small log structures, plainly finished, such as G-IV-C-043, Edward Barnard Farm and G-III-A-049, J. Bunnell Friend Farm, this timber-framed dwelling is comparatively spacious and well-finished. Since few of this buildings' peers have survived, it is not known whether this is a typical or unusual structure for its time. It does, however, represent one aspect of Garrett County's development—the early settlement by Englishmen from the Chesapeake tidewater and mid-Maryland regions.

Moldings finishing the early section of the Coddington house date stylistically no earlier than the 1830's. This suggests that the house was built or remodelled by Samuel Coddington, who bought the farm from William Coddington's estate in 1834. William, a miller, was taxed for the five military lots composing the Coddington farm in 1798. It is not known what his relationship is to Samuel, or whether this is the same Samuel who also appears in the 1798 assessment, owning 2 military lots. In the 1834 sale notice, the property's improvements are described as a "Good Dwelling House, an excellent barn, stables, and so forth." The farm included 180 acres of cleared, fenced, and cultivated land, and "one of the largest and best Apple and Peach Orchards in the county."

The Coddington who built this farmhouse was reflecting a style common in late 18th and early 19th century tidewater Maryland. A long, narrow house one room deep, heated by an exterior stone chimney at either end, of center-hall plan with a room to either side; contrasts sharply with the square, German 3-room plan.

The property transferred to a Frey at some unknown date, then passed from the Frey heirs to Daniel Augustine of nearby Somerset County, PA., in 1871. He probably built the large section of the house that now faces the road. This addition features decorative elements, such as the carved attic window surround and the etched-glass door, seen in other local houses, particularly in Selbysport and Friendsville. This section is typical of well-built houses of the period. It completes a logical building sequence and configuration found in tidewater buildings such as CT-113, Welshpool, in Calvert County.

All interior features except for the mantels remain intact.

The east-facing addition includes a shed-roofed porch across the facade. The solid wall at either end of the porch, which just turns the corner, is lit by paired 6-pane windows. Plain square posts support the porch roof. A one-story enclosed addition on the south gable end may have originated as an open porch. One-over-one sash windows framed in plain flat boards capped by a drip molding light the house. The facades second-story bay above the central entrance is unfenestrated. Gothic-arched windows framed in elaborate trim, similar to those in nearby Selbysport, light the attic in either gable end. At the north end of the west side, an elaborate door opens under the original building's porch. A central pane of etched glass depicts an elk. A cellar entrance appears at the west end of the north side.

A central stove-flue chimney heats the house. The interior has been substantially altered.

The barn stands c. 500 yards east of the house.

Now I will inform you of their Mariagees I don't know that is is of any youse to Say anything about Benjamin's mariage But he is married to Phebe (Y or G?) Squier the other boys is not married Hannah is married to Samuel Lee and Rhoda is Married to Moses Morehouse the rest is not married I Expect for this is the way Potter Stated to me him Self Now if you please See Some lawyer that will Execute this Business the best and the Cheapist and git them as low as you possobly Can I think Mr Howard Said he Could doe the beusiness for me for 20 dollars if he did not go on to Sell and that part I will atten to my Self if you will let me Know when ther is a decree if their is anything more wanting write immediately and give me directions how I must proceed further


