DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Lawson House is situated on Old Morgantown Rd., approx. 8/10 of a mile E of its intersection with Blaine Frantz Road. The house stands at the point where in the early 20th century, the Old Morgantown Road bed, running E to Selbysport, was changed. The old road ran considerably north of the current route, and is visible as a depression that runs directly in front of the house.

The house is a two-story, gable-roofed dwelling with a symmetrical three-bay facade. The house is three bays deep and the facade points SE.

The house rests on a coursed stone foundation, painted white on the NW and SW elevations. On the facade (SE) and the SW elevations the walls are covered with white aluminum siding. On the NE and NW elevations the walls are covered with green-painted German siding. At the N corner, the cornerboards have been cut to resemble uoins and painted beige. There are shadows where similar cornerboards have been removed on the German siding at the W and E corners.

On the first floor of the facade are two modern bay windows with 6 over 6 sash on either side of a central door. All other windows are one over one sash. On the NE and NW elevations, all windows have cornices and shouldered trim. The cornices exhibit symmetrically moulded architraves with central bullseyes. On the facade (SE) and SW elevations, all window trim has been removed. The facade exhibits paired windows in the central bay of the second floor. All windows have louvered shutters, painted black.

The gable roof has cross-gables at the facade (SE) and NW elevations. At the NW elevation, the cross-gable is positioned above the main cornice line, and has a single one over one window. On the facade the cross-gable has double windows. The two gable ends and the facade cross-gable have jigsawn bargeboards at the apex of the gable. The roof is covered with slate shingles in square and fish-scale shapes.

The house has one interior chimney, just to the NE of the cross-gables.

The house has two porches. On the facade is a one-story, one-bay gable-roofed porch covering the central door. The porch has a new stone facade foundation and its roof is covered with asphalt shingles and by two round columns. On the E end of the NE elevation is a shed-roofed porch covering a side door and two windows. The porch roof is covered with asphalt shingles and supported by 4 round columns.

To the SW of the house is a frame, gable-roofed barn and several outbuildings.


