DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This two-part building stands on the southeast corner of the Sand Spring crossroads. It is not known whether the structure is wood frame or vertical plank. Both gable roofs run north-south. The northern one-story section, or store, features a northern gable-end facade. The rear two-story section, or house, faces west.

The two-bay-deep store's facade is protected by a porch positioned under a continuation of the main roofline. A diamond window lights the gable end. Four square posts support the porch roof. A stone foundation supports the porch. The rest of the store sits on a concrete block foundation.

The store's facade features a central, transom-topped door with an arched 2/2 window to either side. The facade of the house also includes a central entrance. 3/1 windows light this section. A hip-roofed porch shelters the facade.

Several additions adjoin the east side. Asphalt shingles cover the walls and roof.


