The Kenneth Savage House is located on the north side of Green Gables Road at a point where the road makes a right turn from east to south. The site consists of a house and, across the road, a springhouse.

The house is a one-story, gable-roofed rectangular dwelling, measuring three bays across the facade (S elevation) and two bays on the sides. A two-story (cellar and first floor) porch runs the length of the east elevation, and a smaller entrance porch shelters the facade door.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Kenneth Savage House is located on the N side of Green Gables Rd. at a point where the road makes a right angle turn from E to S. The site consists of a house and, across the road, a springhouse.

The house is a one-story, gable-roofed rectangular dwelling, measuring 3 bays across the facade (Selevation) and 2 bays on the sides. The ground slopes down from NW to SE, making the foundation more visible on the S and E elevations. A two-story (cellar and first floor) porch runs the length of the E elevation, and a smaller entrance porch shelters the facade door.

The house rests on a coursed stone foundation. The walls are covered with German siding subsequently covered with brown, brick-patterned asbestos siding. The windows are one over one sash with simple cornices and plain board surrounds. The doors, on the facade (S elevation) and the E elevation, have single-paned transoms. The roof is covered with diamond-shaped asphalt shingles. All trim is painted white.

The house has one centrally -placed brick stove chimney. The facade porch has a gable portico. A single-paned window with cornice and surround is set into the tympanum. The porch is supported by four square posts and a simple balustrade of horizontally-placed posts. The porch on the E elevation has two levels. The lower level is screened, the screening stapled to a lattice of boards. Entrance is on the S. Inside there is a door to cellar level of the house. The upper level has a hipped roof supported by 5 chamfered posts.

Across the road to the S is a rectangular, gable-roofed springhouse. The springhouse has a lower level for the spring and an upper storage level. Entrance to the lower level by an exterior half-flight of stone steps is on the N elevation. Entrance to the upper level is by a 3-paneled door on the E elevation. A blocked door appears on the upper level of the W elevation.

The springhouse has a stone foundation. The lower level is divided into two rooms. The cooling room, on the E, has a stone floor and a stone trough Runs along the S wall. The spring runs into the trough from the W. The configuration of the W room is unknown. A door connects it with the E room.

Above the foundation the walls are constructed of studs covered with vertical boards. Two windows on the N elevation have 4 over 4 sashes. The roof is covered with standing seam metal.

To the W of the springhouse is a small shed-roofed storage building, covered with vertical siding.




