DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Although the present entrance to this two-story frame farmhouse is from the south, the original facade faces north. The first story of the L-shaped house has been engulfed by modern additions on the south and east sides of the "ell." The two-bay ell runs south from the three-bay main block.

The original facade includes a central cross-gable decorated with patterned shingles and a central transom -topped entrance. A central brick stove-flue chimney heats the house, which is lit by 1/1 windows. Asphalt shingles cover the roof, while insul-brick sheathes the walls. The house stands on a stone foundation.

The decorative architraves feature chamfered sides and a drip-molded lintel, peaked in the center.


