DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Josephine Coffman Fike House is situated several feet below Blooming Rose Road, between the road and a small creek. The site consists of the house and several small outbuildings.

The house is a two-story, gable-roofed, T-plan house with an asymmetrical three-bay facade. The facade points N. The house rests on a low stone foundation and is covered with asbestos shingle over German siding. The windows are all two over two sash with plain board surrounds. The E window on the facade (N elevation) has a pedimented window head. All other windows have simple cornices. The W windows on the facade and the first floor windows on the S elevation of the main block are double windows. The facade door and the window of the floor above are offset to the E. The roof is covered with standing seam metal.

The sides of the T have been filled in, on the S with a one-story, shed-roofed addition resting on a cinderblock foundation, and on the N with a one-story, shed-roofed porch. The porch roof is supported by square wooden posts and a wooden balustrade. A hipped-roofed porch spans the first floor of the facade. The roof is supported by six turned posts.

The house has one exterior brick stove chimney on the E elevation of the T, and one interior brick stove chimney just E of center in the main block.

The out buildings include a concrete block, gable-roofed garage and several frame outbuildings.


