The Robert L. Hinebaugh House is located a few feet from Trap Run Road, and is surrounded on three sides by trees.

The house is a two-story, gable-roofed dwelling with an asymmetrical three-bay facade. The facade points east. Three shed-roofed additions stretch across the rear (W) elevation. A one-story, shed-roofed porch, enclosed to the south of the facade entrance, covers the facade.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Robert L. Hinebaugh House is located a few feet from Trap Run Road, and is surrounded on three sides by trees. A strip mining operation will soon be started at some distance to the W of the house.

The house is a two-story, gable-roofed dwelling with an asymmetrical three-bay facade. The facade points E. The side elevations of the main block measure one bay wide. Three shed-roofed additions stretch across the rear (W) elevation. A one-story, shed-roofed porch, enclosed to the S of the facade entrance, covers the facade.

The house rests on a low stone foundation and is covered with brown asphalt siding. The windows on the first floor of the main block are one over one sash. To the N of the facade entrance and on the S elevation, are paired windows. On the second floor of the main block all windows are two over two sash. All windows have plain board surrounds. The roof of the main block is covered with asphalt shingles, and an interior brick stove chimney extends from the center of the gable.

The facade porch has a shed roof with a shallow central pediment and exposed rafter ends. The porch has a high stone foundation and the S end of the porch has been enclosed to create a sunporch. The facade entrance is offset to the N and there is an entrance to the sunporch at the corner by the entrance door.

At the rear (W) elevation are three shed-roofed additions. At the N end is a two-story addition which extends slightly beyond the NW corner of the main block. Its roof is an extension of the roof of the main block, creating a shallow catslide. A second addition, one bay wide and one and 1/2 stories tall, extends from the S wall of the first addition. Where the additions join, on the W elevation, is an exterior stone shoulder chimney. A third addition, one bay wide and one story tall, extends from the S wall of the second addition. The roofs of the second and third additions form a continuous shed down to the S. All the additions display a variety of window types, all with plain board surrounds. An exterior brick stove chimney appears on the W elevation at the SW corner.

A few feet from the N elevation of the house is a small outbuilding, possibly a springhouse or storage building. The outbuilding has board and batten siding above a high stone foundation. The gable roof is covered with corrugated tin. The entrance is to the S of center on the E elevation, and the E, N, and W elevations each have one-paned windows.


