## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Grace M. Vansickle house is located approximately 3/10 miles E. of Trap Run Road on a private road. The house faces rising ground and farmland.

The house is a two-story, gable roofed, ell-plan dwelling with a symmetrical three-bay center door facade. The facade points N.

The house rests on a stone foundation, and the facade (N elevation) and the S elevation of the main block are covered with brown asphalt siding over novelty siding. All other elevations, including the ell, are covered with white aluminum siding. The attic level of the S gable end of the ell retains its original novelty siding.

All windows are two over two sash and have plain cornices and plain board surrounds. On the facade, the windows have shouldered trim. In the S gable end of the ell the attic level has two single-paned round windows with plain board surrounds, one on each side of the gable peak. This attic level is covered with novelty horizontal siding above diagonally placed novelty siding.

The roof is covered with asphalt shingle. The house has two interior brick stove chimneys: one in the center of the main block and one at the S gable end of the ell.

The house has two porches. A modern enclosed shed porch fills in the ell on the E and S elevations, and a one-story, hipped-roof porch runs the length of the facade. The facade porch roof is covered with tar paper and is supported by four turned posts. The porch features jigsaw brackets and a jigsaw balustrade.
