Polk Hill area, Maryland/Pennsylvania

Milestone No. ---(214), in the Polk Hill area, marks a new point on the Maryland-Pennsylvania boundary somewhat short of 191 miles west of the northeast corner of Maryland, the beginning of Mason and Dixon's 230.228-mile West Line, the English provincial boundary later known as the Mason-Dixon Line, famous for its historical impact and innovative survey methods. The monument is a very plain dressed marble post with a low pyramidal top, quarried and carved in Cockeysville, Maryland. It is in excellent condition, unaltered, firmly in place; measures about 10 inches square by about 17 inches high above ground; and is embellished only by the capital letter P on the north side facing Pennsylvania, M on the south side facing Maryland, the year 1767 on the east side (when this part of the Line was originally surveyed and marked), and 1902 on the west side (when this new monument was added to a new site established on the Line during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary. On the national and state levels, No. ---(214) is significant primarily as one of the thematic group series of some 248 markers still visually defining the West Line. Locally, as one of the some 42 markers along the present Garrett/Somerset-Fayette county boundary, it is also significant symbolically for its identifiable relationship to the colonial and Civil War heritage of these counties.

The area here is part of the Polk Hill area ridges, sparsely settled, cleared along most of the hilltops and roads, but bordered by woodlands along the slopes. The site is within Election District 2 of Garrett County, MD, and Addison Township of Somerset County, PA; about 1 1/4 miles northwest of the scattered settlement of Mineral Spring, MD; about 3 miles southwest of the town of Addison, PA; about 700 feet west of Collier Hollow; about 1700 feet east of the east edge of the present Youghiogheny River impoundment line; at a point about 5 feet off the east side of (no name) Road/T-300, by a property corner wood post where an old north-south/east-west wire fencing joins, and about 25 feet south of the old pipeline (138-6) about 3 feet above grade level. The cleared land ends here and a dense deciduous woods loops around from the east, to the south and west. The monument seems well protected by this site, despite its proximity to the road.

The monument, identical to 65 other monuments of 1902 set west of Sideling Hill to visually reestablish the Maryland-Pennsylvania boundary, is of a white, fine-grained marble called saccharoidal dolomite or magnesian limestone; was originally cut about 10 inches square by about 4 1/2 feet long, intended for setting about 1 1/2 feet above ground with the remaining 3 feet for setting securely into the ground without the need for a concrete foundation. The letters and numbers are blocky, V-sunk without serifs, and are horizontally aligned as a band around the stone near the top. These, and the top planes and apex are all clear and intact, except for a large chip out of the top southeast corner and lichen covering almost all surfaces.


