Milestone No. ---(218), southeast of the village of Markleysburg, Pennsylvania, marks an additional point on the Maryland-Pennsylvania boundary a little over 193 miles west of the northeast corner of Maryland, the beginning of Mason and Dixon's 230.228-mile West Line, the English provincial boundary later known as the Mason-Dixon Line, famous for its historical impact and innovative survey methods. The monument is a very plain dressed marble post with a low pyramidal top, quarried and carved in Cockeysville, Maryland. It is in excellent condition, unaltered, firmly in place; measures 10 inches square by about 15 inches high above ground; and is embellished only by the the capital letter P on the north side facing Pennsylvania, M on the south side facing Maryland, 1767 on the east side (when this part of the Line was originally surveyed and marked), and 1902 on the west side (when this new monument was added to the Line at a site established during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary. On the national and state levels, No. ---(218) is significant primarily as one of the thematic group series of some 248 markers still visually defining the West Line. Locally, as one of some 42 markers along the present Garrett/Somerset-Fayette county boundary, it is also significant symbolically for its identifiable relationship to the colonial and Civil War heritage of these counties.

Milestone No. ----(218) marks an additional point on the Maryland-Pennsylvania boundary a little over 193 miles west of the northeast corner of Maryland, the beginning of Mason and Dixon's 230.228-mile West Line. It is a very plain dressed marble post with a low pyramidal top, quarried and carved in Cockeysville, MD. It is in excellent condition, unaltered, firmly in place; measures 10 inches square by about 15 inches high above ground; and is embellished only by the capital letter P on the north side facing Pennsylvania, M on the south side facing Maryland, the year 1767 on the east side (when this part of the Line was originally surveyed and marked), and 1902 on the west side (when this new monument was added to a new site established during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary).

The area here is part of the Kemp farm, close to the top of one of a series of hills forming a ridge, mostly open and in cattle pastures (elevation at the site about 1980 feet), with only a few scattered houses along the road. The site is within Election District 2 of Garrett County, MD, and Henry Clay Township of Fayette County, PA; about 1 1/4 miles southeast of the village of Markleysburg, PA; about 1 1/4 miles northeast of the scattered settlement of Asher Glade, MD; at a point about 1200 feet west of Guard Road/T-878 at the Line (and from the Kemp farmhouse), just north of the ^{broad open} hilltop, in the south edge of a light deciduous woods, against the north side of an east-west barbed wire fence separating an open pasture from the woods, and with the old pipeline paralleling the fence a short distance to the north. The site cannot be seen from the road or farm service lane, but easily from the hilltop, all seasons; and is protected by the site and proximity to the fencing and posts.

The monument, identical to 65 other monument of 1902 set west of Sideling Hill to visually reestablish the Maryland-Pennsylvania boundary, is of an off-white fine-grained marble called saccharoidal dolomite or magnesian limestone; and was originally cut about 10 inches square by about 4 1/2 feet long, intended for setting about 1 1/2 feet above ground with the remaining 3 feet for securing below ground without the need for a concrete foundation. The letters and numbers are blocky, V-sunk without serifs, and are horizontally aligned as a band around the stone near the top. These, and the top planes and apex, are all clear and intact, although ^{all surfaces are weathered and} there are inconsequential nicks along the vertical edges and small chips in the top corners.

Milestone No. ---(218) is significant on the national and state levels primarily as one of the thematic group series of some 248 markers still visually defining Mason and Dixon's West Line, the 230.228-mile provincial boundary later known as the Mason-Dixon Line, famous for its historical impact and innovative survey methods. This part of the Line was surveyed and marked in 1767, and the new Cockeysville marble monument added to a new site on the Line established in 1902 during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary. Locally, as one of some 42 markers along the present Garrett/Somerset-Fayette county boundary, No. ---(218) is also significant symbolically for its identifiable relationship to the colonial and Civil War heritage of these counties.


