MASON-DIXON LINE: Milestone No. ---(222A/34) 1767, 1910-11(surveys)
Markleysburg, Pennsylvania vicinity 1911(monument)

In 1911 when set, Milestone No. ---(222A/34) at the southern edge of Division Ridge near Markleysburg not only visually marked an additional point on Mason and Dixon's West Line about 196.48 miles west of the northeast corner of Maryland, but more importantly finally established the northwest corner of Maryland, ending long-standing boundary disagreements between Maryland and Virginia (since 1863, West Virginia). The monument is a large, plain, 4-sided, tapered concrete post, smoothly finished and embellished only by inscriptions. It measures about 19½ inches square at the base, narrowing to about 10 inches near the top; rises about 3 feet 11½ inches high above the ground, with an additional some 3 inches of the top, now dome-shaped; and is in good condition, unaltered. The inscriptions are all legible and intact: on the north side facing Pennsylvania, PA and 1910 (the year when this point was established and decreed correct by the Supreme Court); on the east side facing Maryland, MD; on the south side facing Maryland/West Virginia, NO. 34 (the 34th and northernmost of a series of monuments defining the common boundary of these two states) and the names of the 1910-11 Resurvey commissioners (Samuel S. Gannett, W. McCulloh Brown, Julius K. Monroe); and on the west side, W VA. Although unique in design and construction on the West Line, No. ---(222A/34) is similar to the 26 others set by the commissioners.

Milestone No. --- (222A/34) marks an additional point on the Maryland-Pennsylvania boundary, about 1051 feet west of the preceding (Sinclair) stone, ^{and} established ~~the northwest corner of Maryland~~ during the 1910-11 Resurvey of the Maryland-West Virginia boundary, thus ending the controversy over ~~that line and its intersection with Mason and Dixon's West Line.~~ ^{the correct location of} It is approximately 196.48 horizontal miles west of the northeast corner of Maryland; is a new concrete monument, in good condition, unaltered, set in 1911. Unique on the West Line, it is similar to most of those along the Maryland-West Virginia boundary: a four-sided, tapered post, measuring about 19½ inches square at the base, narrowing to about 10 inches, rising about 3 feet 11½ inches, and capped by a dome-shaped top rising another 3 inches at the center. All faces are smooth, with the following inscriptions in slightly raised rectangular panels: on the north side facing Pennsylvania, PA near the top and the year 1910 at the middle; ~~on the east side, MD,~~ ^{at the middle} on the south side, NO. 34 near the top, and the names of the commissioners at the bottom, Samuel S. Gannett/W. McCulloh Brown/Julius K. Monroe/Commissioners; and on the west side, W.VA. at the middle.

The area here is high in elevation (about 2320 feet at the site), densely wooded, no houses within sight, and uglified by the intersection of two widely-cleared utility swaths (a southeast/northwest transmission line and the east/west Columbia Gas pipeline). ^{the convergence of the northwest corner of} The site forms the Election District 2 of Garrett County, MD, the northeast corner of Grant Township, WV, and south edge of Henry Clay Township of Fayette County, PA. It is at the southern end of Division Ridge, northern end of Thomas Ridge; about 1½ miles southwest of the village of Markleysburg, ^{PA,} about 1¾ miles northwest of the scattered settlement of Asher Glade, MD; about 2½ miles northeast of the scattered settlement of Glade Farms, WV; ^{about 36 feet south of the old pipeline (which} at this point is southwest of the transmission line); on the north side of an old east-west barbed wire fence, in ^{the northeast corner of} a gently sloping deciduous woods; flanked to the east by a low-standing gray granite slant-front tombstone, ^{inscribed as} a Bicentennial commemoration, set by the Boy Scouts of America in 1967, to ^{mark} a MASON-DIXON TRAIL) The site cannot be seen from any road or utility lines when trees are in leaf; and this obscurity and seclusion seem to protect it.

The monument inscriptions are all clear and intact, although there are chips along all edges, particularly the southwest vertical edge and top (now domed, where formerly curved); and the originally smoothed surfaces of each face remain essentially that, though weathered and scratched a bit.

Milestone No. --- (222A/34) is significant on the national and state levels primarily as one of the thematic group series of some 248 markers still visually defining Mason and Dixon's West Line, the 230.228-mile provincial boundary later known as the Mason-Dixon Line, famous for its historical impact and innovative survey methods. This part of the West Line was originally surveyed and marked in 1767, and the present additional point established during the 1910-11 Resurvey of the Maryland-West Virginia boundary, monumented in 1911 with a large concrete post to mark the northwest corner of Maryland and northern endpoint of their common boundary where it meets the southern boundary of Pennsylvania. Locally, as one of some 42 markers along the present Garrett/Somerset-Fayette county boundary (as well as ^{one of} the some 13 found still standing along the present Preston, WV/Fayette county, PA boundary), No. --- (222A/34) is also significant symbolically ^{not only} for its identifiable relationship to the colonial and Civil War heritage of these counties / ^{along} the West Line, but also for its ^{final} settlement of the longstanding controversy over the correct Maryland-Virginia (and later, West Virginia) boundary.



BOUNDARY MONUMENT NO. 34

At the Northwest Corner of Maryland

Erected August 20, 1911, by commissioners for Maryland, West Virginia, and the United States, in accordance with a decree entered by the Supreme Court of the United States, May 31, 1910.

It marks the point where the commissioners' boundary line, running northward from Monument No. 1, intersected the historic Mason and Dixon line. The monument is inscribed as follows:

On the north side: PA. and 1910

On the east side: MD.

On the west side: W.VA.



No. 32 The site was a key point in establishing the northern end of the boundary. The Spanish oak marked the corner of two properties to the west and was in a line of the adjacent property to the east. The removal of the tree itself was no small project. Perhaps symbolically, in addition to the usual inscriptions, Monument No. 32 is marked "Span Oak."

Small Not shown on the U.S. Geological Survey maps. On Fike's Ridge, a spur or knob of Sickle Hill, 3,070 feet, North $0^{\circ}04'55''$ East, from Monument No. 32. Erected August 22, 1911.

No. 33 On the north side of Squire Fike Road about 3,000 feet west of its intersection with Glade Road. Distance from previous monument, 2,220 feet, North $0^{\circ}04'55''$ East. Erected August 22, 1911.

Small On Thomas Ridge 4,550 feet, North $0^{\circ}04'55''$ East, from Monument No. 33. Not shown on maps of the U.S. Geological Survey.

No. 34 On the Mason and Dixon line about 1,000 feet west of Thomas Road and on the south side of the pipeline right-of-way. About $1\frac{1}{2}$ miles southwest of Markleysburg, Pennsylvania. This stone marks the northwest corner of Maryland, and the northwest corner of Military Lot 2927 on the Deakins plat. The commissioners' journal indicates that it was not precisely placed because at that point the Maryland and Virginia tracts overlapped about four rods (66 feet). Distance from the previous monument, 2,460 feet, North $0^{\circ}04'55''$ East.

Monument No. 34 is readily accessible by way of the pipeline right-of-way, west from Thomas Road, but it is not readily visible when the trees and ground cover are in leaf. It is marked as follows: On the north side, PA. and below, the date, 1910; on the east side, MD.; on the west side, W.VA.;




