DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Adam Oester farm consists of a frame dwelling, frame barn, and several frame outbuildings. It is located on a dirt lane running 2/10 mile north and east of US Route 40, approximately 1 7/10 miles W of its intersection with US Route 219 South.

The farmhouse is a two-story, gable-roofed, ell-plan dwelling with a symmetrical, three-bay facade. The facade points SW. A one-story, shed-roofed porch runs the length of the facade, wraps around the SE elevation, and fills in the ell on the SE and NE elevations.

The house rests on a stone foundation and is covered with grey asphalt siding. The windows are one over one sash with cornices and plain board surrounds. On the NW side on the first floor is a diamond-shaped single pane window, also with a cornice and plain board surround. The roof is covered with asphalt sheeting.

The house has two flues: one interior flue at the ridge line of the main block, and one exterior flue at the gable end of the ell, on the NE elevation. The porch is supported at the W side of the facade, by square columns on pedestals. Elsewhere the porch is supported by square wooden posts.

To the NW of the house are a frame barn and several frame outbuildings.


