The house is a one and one half story, gable roofed dwelling measuring two bays long by one bay wide. The facade points east. A gable roofed addition extends from the north elevation.

Tradition states that this house may once have been a schoolhouse.

**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Klotzbaugh house is located in Winding Ridge, in the midst of rolling farmland. The neighborhood contains several newer homes as well. The ground slopes down to the W of the house.

The house is a one and one half story, gable roofed dwelling measuring two bays long by one bay wide. The facade points E. A gable roofed addition extends from the N elevation.

The house rests on a low stone foundation and is covered with beige asbestos shingle. All windows are three over one sash with plain mitred surrounds. On the W elevation there are two sets of paired windows. On the S gable end, at the W end, a door has been enclosed with a shed-roofed, glassed-in stormporch. All roofs are covered with asphalt shingles.

The addition on the N elevation rests on a cinderblock foundation and is covered with beige asbestos shingles. The facade door is on the E elevation of the addition.

The house has two chimneys: an interior brick stove chimney at the center of the main block, and a modern cut stone chimney on the W elevation of the addition.

STATEMENT OF SIGNIFICANCE

Tradition states that this house may once have been a schoolhouse. If so, it has been severely altered. However, Scharf states that there was a school at Winding Ridge in 1882. The basic configuration of the house is similar to that of other schoolhouses in Garrett County. Compare G-II-A-045 (Asher Glade School) and G-II-B-191 (Rich Hill School).


