DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Jenkins-Devine House is located on MD Route 42, approximately two miles W of Rt. 219S. The house stands close to the road and behind the land runs down to Bear Creek.

The house is a two-story, gable-roofed dwelling measuring four bays across the facade and two bays on the gable ends. The asymmetrical facade points N. A one-story, shed-roofed porch runs the length of the facade. A one-story, shed-roofed addition runs across the S elevation.

The house rests on a coursed stone foundation and is covered with yellow german siding. The windows are two over two sash with plain board surrounds. On the first floor of the facade, the door is set E of center. Just E of the door is a one over one sash window with a small rectangular pane at the top and a large one at the bottom. A similar window is set farther to the W of the door.

The roof is covered with standing seam metal. A large modern brick chimney is set W of center at the ridgeline of the roof. On the S elevation, only the W end of the addition seems to be contemporary with the house. The remaining section is constructed of cinderblock. The interior of the house is unknown.


