The house on the Williams Farm is a frame, two story, gable-roofed building on a coursed, squared stone foundation. Its basic configuration is a T-plan that consists of a three bay by two bay main block with a two bay by one bay rear wing. The facade has a symmetrical three bay, center door arrangement with an unfenestrated second floor center bay. A flat-roofed porch supported by three square columns shelters its two northern bays. All windows are two over two sash. The facade door has a large frosted glass window with an applied carved garland decoration and two raised panels below. German siding covers the exterior walls, however, asbestos shingles have been applied over the siding.

A frame bank barn, a frame springhouse, a corn crib, a granary, a machine shed, and a chicken coop are also on the property.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Williams Farm is located on the south side of Mill Run Road approximately .2 mile east of its intersection with Friendsville-Addision Road. A dwelling, a barn, and several outbuildings are set back from the road on the east side of Hessian Run.

The house is a frame, two story, gable-roofed building on a coursed, squared stone foundation. Its basic configuration is a T-plan that consists of a three bay by two bay main block with a two bay by one bay rear wing. The facade (W elevation) has a symmetrical three bay, center door arrangement with an unfenestrated second floor center bay. A flat-roofed porch supported by three square columns shelters its two northern bays. A shed-roofed porch with a small enclosure is attached to the rear of the main block on the south side of the wing, and another shed porch extends the length of north elevation on the wing. All windows are two over two sash with plain board surrounds and molded dripboards. The bay window on the east endwall consists of a pair of two over two sash that project about a foot from the wall. The facade door has a large frosted glass window with an applied carved garland decoration and two raised panels below. The rear doors are raised four-panel doors. German siding covers the exterior walls, however, asbestos shingles have been applied over the siding. The roof is covered with asphalt roll roofing and has two cinderblock, interior stove chimnies.

The bank barn, which is located south of the house, is a frame, gambrel-roofed structure on a stone foundation. German siding covers the exterior walls and louvered ventilation panels pierce both endwalls.

A frame, gable-roofed springhouse on a dry-laid stone foundation sits approximately 25 feet southeast of the house. This small building is covered with german siding on the exterior and is lined with bead-edged board on the interior. A corn crib, a granary, a machine shed, and a chicken coop are also on the property.
