DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Charles R. Bowser House is located on the Accident-Friendsville Road, about a mile west of Accident. The site is surrounded by rolling farmland.

The house is a two story, gable-roofed dwelling with a three-bay, center-door facade. The facade points north. The first floor of the facade has been covered by an enclosed, shed-roofed porch. The south elevation has been covered by a one-story, shed-roofed addition.

The house rests on a concrete-covered, cut stone foundation and is covered with asbestos shingles. The windows are one over one sash with plain mitred surrounds. The roof is covered with standing seam metal.

The addition on the south elevation has a foundation of large bricks and is otherwise similar to the main block. The facade door on the sunporch is sheltered by an aluminum hood. The house has one exterior stove chimney built of cinderblock on the west elevation.

The site includes a frame bank barn, facing north. The barn is covered with vertical boards.


