DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Gerald Glass Tenant Farm is located below Sam Friend Road, approximately ½ mile north of Bear Creek. The farm consists of a house, log barn, and several outbuildings. Two of these outbuildings are also log.

The house is a two-story, gable-roofed, ell-plan dwelling with a three-bay, center-door facade. The facade points NE. The first floor of the facade is covered by a hipped-roofed, enclosed porch and the ell is filled in on the SW and SE elevations by a one-story enclosed brick porch.

The house rests on a rough stone foundation and is covered with german siding. The windows are three over one sash with simple cornices and plain board surrounds. On the NW elevation two windows are two over two sash. The roof is covered with standing seam metal.

The house has two brick interior stove chimneys, one at the center of the main block and one at the SW gable end of the ell.

The facade porch has a battered wall and modern sash windows. The hipped roof is covered with tarpaper. The ell porch has modern windows and its shed roof is also covered with tarpaper. The interior of the house is unknown.

West of the house is a one-story, gable-roofed, log outbuilding. On the NE (entrance) elevation is white german siding: on the other elevations the logs are exposed. The logs are chinked with boards and daubed with cement, and the logs are V-notched. The outbuilding rests on a poured concrete foundation and its roof is covered with tarpaper.

Northwest of the first outbuilding is a log springhouse. The springhouse rests on a stone foundation and the logs are V-notched. The gable roof is covered with corrugated metal. The NE elevation of the springhouse was previously open but has been filled with rock-faced concrete block.

East of the house, close to Sam Friend Road is a large double-pen log barn. The pens are single-saddle-notched and are exposed only on the NE elevation. On the SW & NW elevations additional space has been built on to the barn, enclosing the pens. The newer portions of the barn have a rock-faced concrete block foundation. On the NW elevation is a one-story addition built of rock-faced concrete block. The gambrel roof is covered with corrugated metal.






