DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Joseph Fazenbaker House is located on the Accident-Friendsville Road, approximately 2.4 miles west of Accident. The house is surrounded by woods.

The house is a true one and a half story, gable-roofed dwelling with an asymmetrical facade. The facade points northeast. One-story, shed roofed additions cover the northeast and southwest elevations.

The house rests on log sills supported by stone footings. The plank-constructed walls are covered with brick-patterned asphalt siding over weatherboarding. The windows are a variety of sash; two over two, three over two, and three over one are represented. On the upper half story of the facade are six-pane half windows. On the facade the door is offset to the southeast from center on the one-story addition.

The roof is covered with asphalt roll siding. The house has one central white brick stove chimney with a rebuilt cap. The facade addition walls are built halfway up in cinderblock and above are vertical boards. The roofs of both additions are asphalt roll siding.

The interior is unknown. West of the house are several small frame outbuildings. The entire site is abandoned and in deteriorated condition.

STATEMENT OF SIGNIFICANCE

According to a neighbor, this property once belonged to Joseph Fazenbaker. He may have acquired it when he married Mary Catherine Schroyer, part of the Schroyer family which had previously owned this property and that of the next site, G-II-B-205, the John Wesley Schroyer House. The house is an example of a type of construction common in Garrett County in the 19th century and its configuration suggests that its builder may have been of modest means.


