DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Kermit Yoder House is on Accident-Bittinger Road, about a quarter-mile east of Accident. The house sits back from the road, northeast of the King House, G-II-B-215.

The house is a two-story, gable-roofed, ell-plan dwelling with a symmetrical, three-bay facade. The facade points south. A one-story, gable-roofed porch covers the facade. The ell has been filled in on the north and west elevations with a shed-roofed addition which creates a cat slide with the west slope of the roof of the ell.

The house rests on a foundation of oversized bricks. The walls are covered with asphalt shingle siding and the roof is similarly covered. The windows are one over one sash with plainboard surrounds. The house has one interior brick stove chimney in the ell where it joins the main block. The porch roof is supported by square, tapering columns.

The interior of the house is unknown.


