DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Mary Jenkins House is located off Lawrence George Road, above one and three-quarters mile northwest of Accident. The house is surrounded by fields and woodland and is situated in a crevice between two hills.

The house is a two-story, gable-roofed dwelling measuring five bays across the facade by two bays on the gable ends. The facade points east. A one-story, shed-roofed porch runs the length of the facade and wraps around the northeast corner to cover the north gable end.

The house rests on a stone foundation and is covered with brown brick-patterned asphalt siding. The windows are two over two sash and each, including the attic windows on the south gable end, has an elaborately jigsawed window head with a plain surround. The facade door is unknown.

The roof is covered with tarpaper and the box cornice returns on the gable ends. There is one interior stove chimney on the north gable end. The facade porch roof is covered with tarpaper and is supported by turned posts.

The interior is unknown. The site includes a frame barn.


