Milestone No. ---(205), at the site of a former large mound of earth, marks a point on the Maryland-Pennsylvania boundary a little more than 184 miles west of the northeast corner of Maryland, the beginning of Mason and Dixon's 230.228-mile West Line, the English provincial boundary later known as the Mason-Dixon Line, famous for its historical impact and innovative survey methods. The monument is a very plain, dressed marble post with a low pyramidal top, quarried and carved in Cockeysville, Maryland. It is in excellent condition, ^{though leaning slightly to the north} unaltered, firmly in place; measures about 10 inches square by about 1½ feet high above ground; and is embellished only by the capital letter P on the north side facing Pennsylvania, M on the south side facing Maryland, the year 1767 on the east side (when this site was originally surveyed and marked with a cairn), and 1902 on the west side (when this new monument was added to the remains of the cairn at the time of the 1900-03 Resurvey of the Maryland-Pennsylvania boundary). The ^{however} mound was no longer distinguishable at the time of the 1981 field inspection. On the national and state levels, No. ---(205) and mound site are significant primarily as being among the thematic group series of some 248 markers still visually defining the West Line. Locally, as among the some 42 markers along the present Garrett/Somerset-Fayette county boundary, they are also significant symbolically for their identifiable relationship to the colonial and Civil War heritage of these counties.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Milestone No. ---(205), at the site of a former large earth mound, marks a point on the Maryland-Pennsylvania boundary a little more than 184 miles west of the northeast corner of Maryland, the beginning of Mason and Dixon's 230.228-mile West Line. The monument is a very plain dressed marble post with a low pyramidal top, quarried and carved in Cockeysville, MD; is in excellent condition, unaltered, ^{though leaning slightly to the north} firmly set; measures about 10 inches square by about 1½ feet high above ground; and is embellished only by the capital letter P on the north side facing Pennsylvania, M on the south side facing Maryland, the year 1767 on the east side (when this site was originally surveyed and marked with a cairn), and 1902 on the west side (when this new monument was added to the remains of the mound at the time of the 1900-03 Resurvey of the Maryland-Pennsylvania boundary). The mound is no longer distinguishable.

The area here is the northeast corner of a ^{sizeable} future housing development, "Hemlock Acres" (now with only a few cabins), partly cleared on the Maryland side, and surrounded by dense woodlands. The site is within Election District 5 of Garrett County, MD, and Addison Township of Somerset County, PA; about 1¼ miles due east of the small scattered settlement of Strawn (formerly Oakton), MD/PA; ^{at the north edge} near the top of a ^{unnamed} high hill (elevation at the site about 2740 feet); at a point about 15 feet west of the stone foundation ruins of ^{old, abandoned oil} the pipeline gatehouse and about 10 feet north of an old east-west barbed wire fence, in the scraggly fencerow separating the ^{wooded} development land on the south from the cleared pipeline. It cannot be seen from the development road, but is easily seen from the pipeline and gatehouse ruins; and appears protected by the site remoteness and inconspicuousness.

The monument, identical to 65 other monuments of 1902 set west of Sideling Hill to visually reestablish the Maryland-Pennsylvania boundary, is of a white, fine-grained marble called saccharoidal dolomite or magnesian limestone; was originally cut about 10 inches square by about 4½ feet long, intended for setting about 1½ feet above ground with the remaining 3 feet for setting into the ground, thus eliminating the need for a concrete foundation. The letters and numbers are blocky, V-sunk without serifs, and are horizontally aligned as a band around the stone near the top. These, and the top planes and apex are all clear and intact; though there is a chip out of the top southwest corner and small nicks along several of the vertical edges. According to the 1900-03 Resurvey notes (MGS Vol. 7, 1908, p. 98): this monument was "placed at the site of a former large earth mound..."(which had been) "almost obliterated in the building of **CONTINUE ON SEPARATE SHEET IF NECESSARY** gate house for the oil pipe line..." STATEMENT OF SIGNIFICANCE

Milestone No. ---(205) and its mound site are significant on the national and state levels primarily as being among the thematic group series of some 248 markers still visually defining Mason and Dixon's West Line, the 230.228-mile English provincial boundary later known as the Mason-Dixon Line, famous for its historical impact and innovative survey methods. This site was surveyed and marked with a cairn in 1767, and the new Cockeysville marble monument added to the remains of the cairn in 1902 during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary. Locally, as among the some 42 markers along the present Garrett/Somerset-Fayette county boundary, ^{and the mound site} No. ---(205) are also significant symbolically for their identifiable relationship to the colonial and Civil War heritage of these counties.


ACCIDENT QUADRANGLE
