DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This vertical plank constructed house is situated in a hilly, semi-wooded area on Dunhill Road approximately 1½ miles west of Rt. 495. The house faces south. It is a two story, three-bay by two-bay structure with a gable roof. A wooden porch supported by plain wood posts extends across both the facade and rear, north elevations. Entrances appear at both porches.

The house has an interior brick gable end chimney and an exterior cinderblock gable end chimney both at the west elevation. The house is lit predominantly by 1/1 and 2/2 sash windows. Plain flat boards frame the windows.

The house rests on a stone foundation. Aluminum siding covers the house.
