Public/private

Milestone No. ---(202) and its large mound of earth on Packhorse Mountain ridge mark a point on the Maryland-Pennsylvania boundary close to 182½ miles west of the northeast corner of Maryland, the beginning of Mason and Dixon's 230.228-mile West Line, the English provincial boundary later known as the Mason-Dixon Line, famous for its historical impact and innovative survey methods. The monument is a very plain dressed marble post with a low pyramidal top, quarried and carved in Cockeysville, Maryland. It is in good condition, unaltered, firmly set; measures 10¼ inches square by about 14 inches high above the mound; and is embellished only by the capital letter P on the north side facing Pennsylvania, M on the south side facing Maryland, the year 1767 on the east side (when this site was originally surveyed and marked with a cairn), and 1902 on the west side (when this new monument was added to the remains of the cairn during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary). The large mound of earth, believed original, is a fine one in excellent condition, and measures about 15 feet in diameter by about 3 feet high at the center, where the monument replaces an original wood post. On the national and state levels, No. ---(202) and the mound are significant primarily as being among the thematic group series of some 248 markers still visually defining the West Line. Locally, as among the some 42 markers along the present Garrett/Somerset-Fayette county boundary, they are also significant symbolically for their identifiable relationship to the colonial and Civil War heritage of these counties.

**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

Milestone No. ---(202) and its large mound of earth on Packhorse Mountain ridge mark a point on the Maryland-Pennsylvania boundary close to 182½ miles west of the northeast corner of Maryland, the beginning of Mason and Dixon's 230.228-mile West Line. The monument is a very plain dressed marble post with a low pyramidal top, quarried and carved in Cockeysville, Maryland; is in good condition, unaltered, firmly set; measures 10¼ inches square by about 14 inches high above the mound; and is embellished only by the capital letter P on the north side facing Pennsylvania, M on the south side facing Maryland, the year 1767 on the east side (when this site was originally surveyed and marked with a cairn), and 1902 on the west side (when this new monument was added to the remains of the cairn during the 1900-03 Resurvey of the Maryland-Pennsylvania boundary). The large mound of earth, believed original, is a fine one in excellent condition, and measures about 15 feet in diameter by about 3 feet high at the center.

The area here is part of the Packhorse Mountain ridge, <sup>high in elevation (about 2700 feet),</sup> densely forested on the west side which becomes part of Savage River State Forest in Maryland, and a cleared stretch on the east following Zehner Road. The site is within Election District 3 of Garrett County, MD, and Addison Township of Somerset County, PA; about 1¼ miles northwest of the scattered <sup>about 2000 feet east of Puzzley Run;</sup> settlement of Hi-Point, MD; at a point about 15 feet west of Zehner Road/T-376, about 100 feet south of the pipeline, well camouflaged just <sup>the east edge of</sup> inside the ferny woods. It can be seen from the road, but not readily, and is protected by the inconspicuousness of the site.

The monument, identical to 65 other monuments of 1902 set west of Sideling Hill to visually reestablish the Maryland-Pennsylvania boundary, is of a fine-grained marble called saccharoidal dolomite or magnesian limestone; was originally cut about 10 inches square by about 4½ feet long, intended for setting about 1½ feet above ground (or mound) with the remaining 3 feet for setting into the ground, thus eliminating the need for a concrete foundation. The letters and numbers are blocky, V-sunk without serifs, and are horizontally aligned as a band around the stone near the top. These, and the top planes and apex are all clear and intact; although there are chips at all top corners and along all vertical edges, and all surfaces are scaley with lichen. The mound is compact, and undisturbed, covered with leaves and weeds but clearly defined.


