

The MacNess Beachy farmhouse is a two story four-bay by two-structure with a gable roof. The house rests on a cut stone foundation, except for the rear addition which rests on a rock face, concrete block foundation. The original German siding is seen on the first story facade; elsewhere, octagonal asphalt shingles cover the house.

A barn is located north of the house.
