DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This log and frame farmhouse is situated in a hilly, semi-wooded area on Rt. 40 approximately 1¼ miles east of Keyser's Ridge and Rt. 219. The house faces north. It is a two story, three-bay by one-bay, gable roof structure. The rear, south, elevation roof slopes down covering a story-and-a-half shed addition. A wooden porch supported by large square posts extends the length of the facade. The house is entered from the facade and the west elevation.

2/2 sash windows light the house. The windows are framed with plain flat boards. 1/1 sash windows are on the first story facade. The cellar is entered at the east elevation of the rear addition. The main block, constructed of logs, is covered with asphalt shingles except where exposed, at the east elevation. The vertical planks of the rear addition are exposed in the half story but are covered with tar paper in the first story. Corrugated metal covers the roof.


