DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame house is situated in a hilly area on Fire Clay Road, approximately 3/4 mile northwest of Rt. 495. The house faces southeast. It is a two story, two bay by three bay gable roof structure, gable end front with a two bay by one bay ell off the southwest, side, elevation. A wooden porch supported by turned posts with square balustrades runs across the facade and southwest elevations of the main block. A porch of the same type is located at the rear, northwest, elevation. The facade entrance is located at the south end. An entrance also is located on the southeast elevation of the ell and at the center of the rear elevation.

An exterior gable end brick chimney is located at the southwest elevation of the ell. 1/1 sash windows framed in plain surrounds with drip cap window heads light the house. The cellar is entered below the rear porch.

Asphalt shingles cover the house and the roof.


