DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This brick farmhouse is situated in a hilly area on Casselman River Road approximately 3/4 mile north of Rt. 40. The house faces south. It is a two story, three bay by three bay structure with a gable roof. A wooden porch supported by slightly tapered round columns extends the length of the facade and the east elevation. The house is entered from the central facade entrance and by two entrances symmetrically located at the east elevation, all with transoms.

The house has two central brick chimneys. One over one sash windows, with concrete sills and lintels, light the house. Two small 1/1 sash windows with drip cap molding are located in both gable ends. The house rests on a concrete foundation. The house is constructed of brick with diamond shaped asphalt shingles located in the gable ends. Asphalt shingles cover the roof.

A barn resting on a stone and block foundation is located on the property.


