DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This frame house is situated in a hilly area off Dorsey Hotel Road approximately one mile north of Grantsville and Rt. 40. The house faces south. It is a two story, four bay by two bay structure with a gable roof. A wooden porch supported by chambord posts extends across the west half of the facade to a one story shed addition. This addition continues around to the east elevation to a small porch at the north end. This porch is also supported by chamford posts. The house is entered from the central facade entrance and an entrance at the east porch, both with transoms.

An exterior brick chimney is located at the east gable end. Two over two sash windows, with drip cap molding, light the house. Single pane windows are located in the gable ends. The cellar entrance is located at the east elevation of the shed addition. The house rests on a stone foundation. Asbestos shingles cover the exterior with corrugated metal on the roof. Two barns and a sugar camp are located on the property.


